SUBMISSION OVERVIEW

- 1. After registration, you will receive an Additional Form from Submittable, for each submission.
- 2. This Form will collect additional information about the project along with your proof of 2030 Signatory, Project Presentation, Additional Images and, if required, proof of DDX Registration. Please see below for further clarification.
- 3. Design Awards Entries (only) will need to provide energy metrics to be eligible for an Honor award.

Each completed submission package must follow these guidelines, via Submittable.

Your entry will be disqualified if it does not contain the required elements:

- PDF Presentation (Do **Not** Reveal Firm Name or Architect within the PDF Presentation)
- Proof of 2030 Signatory
- Proof of project's DDX Registration (Design Awards only, excluding Installation and Cityscape typologies)
- Additional high-res Images

Additional Information:

- In the event that the jury selects your project, it will be credited based on the information you provide in the Additional Form
- The submission MUST be approved by the Designer-In-Charge or by a Principal with the firm in order to qualify.

Please note that if you are entering multiple projects, each project must be submitted individually. More detailed information regarding the Design and NEXT LA submission requirements is provided in the subsequent pages of this document.



DETAILED SUBMISSION REQUIREMENTS

A. PDF Presentation

Please provide a single PDF ile (maximum 10 pages) containing your project's presentation. Presentations are
viewed by the jury as a means to see and understand your project. You may use any program to layout your
presentation, but follow the AIALA PowerPoint template available on the Design Awards home page for format
and content.

10 PAGE (max.) PDF PRESENTATION



- There should be **no text or image(s) identifying designer/firm** included in the PDF presentation.
- ALL JUDGING IS ANONYMOUS.
- Place project **Location** and **Typology** on each page, as noted on template.
- At a minimum the PDF presentation should include three (3) photos of the project and one (1) text page.
- Re-use/renovation/restoration entries are encouraged to show images of previous conditions for reference.
- Captions are optional.



DETAILED SUBMISSION REQUIREMENTS

B. Digital Images

For use by AIA Los Angeles on our website, Pinterest gallery, LinkedIn, Instagram and Facebook, and as printed and digital display at the AIALA Design Awards - please provide the following:



- Images may not be composites or collages must be a single, representative image of the submitted project.
- All images should be clear of identifying text or marks.
- All photographer credits for images must be indicated in the project form.
- Additional images will be requested at a later date from entrants receiving awards.

SUBMISSION DEADLINE: AUGUST 1, 2024

PROJECT TYPOLOGIES

Each project must be entered into a specific Project Typology. Typologies are intended for ease of jury coordination only; awards are not bestowed per typology. The Project Typologies are defined as follows:

Adaptive Re-Use/Renovation/Historic Preservation (ARHP): projects of all types that are designed in consideration of existing built conditions.

Affordable Housing (AH): projects defined as affordable housing by the US federal government.

Cityscapes (CS): projects that engage a broad range of circumstances, including (but not limited to) urban design, master planning, outdoor public spaces, and/or campus planning.

Commercial/Mixed-Use (CMU): projects intended for commercial or mixed commercial and residential uses, including (but not limited to) office, retail, hospitality, industrial, and/or transit-oriented developments.

Competitions (COM): NEXT LA AWARD PROJECTS ONLY: Projects entered for any type of design competition that has been sponsored by an acknowledged civic or professional organization for the purpose of selecting a project for construction; both winning and non-winning competition entries are acceptable.

Educational (EDU): projects intended for all levels of education, including (but not limited to) preschool, K-12, college and university, and/or adult education.

Healthcare/Institutional/Civic (HIC): projects intended for public or governmental uses, including (but not limited to) government buildings, libraries, healthcare, museums, and/or performing arts centers.

Interior Architecture (IA): projects that involve the interior architecture of a space only, in a project type including (but not limited to) office, retail, hospitality, entertainment, museum, educational, and/or residential.

Installations (INST): projects intended for temporary status, including (but not limited to) museum and gallery exhibitions, trade show exhibits, and/or follies.

Multi-Unit Residential (MUR): projects intended for habitation by multiple tenants, including (but not limited to) condos, apartment buildings, co-ops, affordable housing, public housing, townhouses, duplexes, and/or small-lot projects.

Single-Family Residential (SFR): projects intended for single-family habitation.

Temporary Shelter (TS): temporary housing or portable housing or modular housing to transition people from streets to housing, or serve during environmental disasters.

TIPS & TRICKS

The following are suggested tips for creating strong award entries. These are NOT requirements. Your entry will not be judged differently for lack of any of the below information.

Submit professional photographs of your entry, if possible. Starting and ending with good Photography, while an investment, is key to the best presentation of built work.

Reach out to your engineering partners early for the requested energy metrics if you are submitting for a Design Award, and want to be eligible for an Honor Award.

Provide a diagram(s) that explains the main idea or parti of your entry. Consider providing a name for your project that describes its main idea. Strong conceptual clarity is important. How did the architect take various programmatic concerns and look beyond straightforward solutions to create exceptional, innovative design responses?

If context is important to the project, consider including a site plan, site elevations/sections, diagrams or any additional documentation to explain relationships.

For renovations, restorations, additions, consider representing existing conditions as 'before' with new work as 'after.' Existing conditions should appear as subordinate images to the featured new design.

Include details: interiors, details, secondary and tertiary views or sides to provide a clear understanding of the extent and quality of the finished project.

Consider organizing images into a narrative sequence to describe the intended experience of the project. For example: from curb to entry or from public to private space.

Include images/documentation that foregrounds the unique or innovative aspects of your design/solution.

The AIA strives for inclusivity and diversity among members and through the work produced by its members. With this goal in mind, demonstrate how your entry addresses community to include the interests of diverse populations or neighborhoods.

STATEMENT OF ELIGIBILITY

This submission must be approved by the Designer-In-Charge or by a Principal with the firm, in order to qualify for the awards competition.

- The submitting entrant has reviewed the information shown above for completeness and accuracy for use in publicity releases for newspapers and magazines.
- The submitting entrant verifies that the entry is entirely the work of those listed on the project submission form.
- The submitting entrant understands that if this project is selected for an award, he/she will provide additional quality images upon request in a timely manner for printed and digital promotion. If the undersigned entrant does not supply these images when requested, he/she forgoes the opportunities for promotion.
- The submitting entrant declares that he/she does not employ unpaid intern architects and neither does any practice of which he/she is an owner or manager.
- The submitting entrant into the AIALA's DESIGN AWARDS | NEXT LA programs hereby accepts and acknowledges that the
 awards are retrospective in nature and based on a subjective evaluation of the judges, and that an entrant has no right,
 contractual or otherwise, to be recognized as an AIALA DESIGN AWARDS | NEXT LA winner.
- AIALA's DESIGN AWARDS | NEXT LA winners are determined and prizes are awarded in the sole and absolute discretion of the Jury.
